3. I warrant and represent that I am the sole author of the Project and that the same is registered. I further warrant and represent that to the best of my knowledge the Project and all elements thereof are my original creations and do not violate any copyright, proprietary rights, rights of confidentiality, or other rights of any person or entity and that no third party has any rights, title or interest therein or thereto except as may be specifically identified on the Project in writing.
